

Study Abroad and 1+1 Master agreement between

2. PURPOSE

The aim of this agreement is to promote and facilitate closer ties between Chung Hua university (hereinafter CHU) and *Elisava Barcelona School of Design and Engineering* (hereafter, *Elisava*) that is affiliated to the *Universitat Pompeu Fabra*

By this document it is agreed that CHU will send students to study at *Elisava* during periods of one or two academic semesters under the Study Abroad programme or a Master Degree.

3. DURATION OF AGREEMENT

The term of this agreement begins on the date of signing and is established for a period of 5 years, which will be extended for one year if none of the parties communicates its will not to continue it in writing to the other party, with a minimum of six months notice. The party who withdraws will ensure completion of the course or courses that are conducted on the basis of this agreement.

4. PROCEDURES OF ADMISSION



The procedure of admission will be the following one:

- a. The student will fill in the pre-register completing the process on the website at www.elisava.net, upload the first set of documents, as instructed on the required fields.
- b. *Elisava* will consider the acceptance of students, if credited to meet the legal requirements for access and if there is availability at the time of the request.
- c. *Elisava* will send a "letter of pre acceptance".
- d. Each student must assume the payment of tuition fees according to prices fixed by the *Elisava* and published in the website www.elisava.net.
- e. The student will send the final documents to be enrolled and pay the tuition fee directly to *Elisava*. The student can pay by credit card or bank transfer, only in the second case the student will send the payment proof to Admissions Department.
- f. *Elisava* will confirm receipt of the tuition fee and send the letter of final acceptance, and the student will be able to apply for (if necessary) a student visa.
- g. Arrangements, if requested by the student and previous agreement with the *Elisava*, will be made with regard to language training, housing or transport.

Elisava will not be responsible for the student obtaining a visa.

If the student fails to send any relevant documents, fails to honour any tuition fees, fails to appear for the first teaching sessions or drops out during the programme, the student will be subject to any regulations stated by *Elisava*.

5. PERIOD OF STUDY

Students may be enrolled for the full academic year or for one Semester in the Fall or Spring.

6. PROGRAMME DESCRIPTION

The programme **ELISAVA** offers to CHU students is the following:

Students from CHU will be allowed to take a 1+1 Master being the first year at CHU and the second year a 60 ECTS own Master Degree at *Elisava*.

7. INFORMATIVE MATERIAL

Elisava may provide informative material that can only be used by CHU for the purpose of ensuring compliance with this agreement.

8. CERTIFICATION

On completion of the programme students will obtain a certificate of the programme by *Elisava and Universitat Pompeu Fabra* if they take the Study Abroad Programme or a Master Degree issued by *Elisava* and the IDEC of the *Universitat Pompeu Fabra*. *Elisava* will neither be responsible to validate it at the university of origin of the students, nor responsible of the acceptance or issuance of the final Master degree at CHU.

However, by this agreement CHU agrees to give academic validation to the studies done by CHU's pupils at *Elisava*.

9. PROHIBITION ON ISSUANCE OF TITLES

CHU may not issue diplomas, certificates or other document on behalf *Elisava* or *Universitat Pompeu Fabra*, nor be able to use their names logos and images, except with promotional purpose only result of this collaboration and with the prior consent expressed by solid evidence by *Elisava*.

10. PAYMENT INSTRUCTIONS

Prices for all programmes are listed and regularly updated on *Elisava*'s web page. CHU students will have to arrange payment for the tuition 14 days after the receipt of the corresponding invoice of *Elisava* to the following Bank channel:

11. LIABILITY

CHU recognizes, explicitly, that *Elisava* does not assume any responsibility for the activities of any kind that students perform in our country outside the classes of the hired programme and such liability is attributable in exclusive to that entity.

12. CONFIDENTIALITY AND PROTECTION OF PERSONAL DATA

The parties expressly recognize that all data provided to it by the other parties, or which can be accessed according to the clauses above, are strictly confidential and must maintain absolute confidentiality about them.

The parties shall take the necessary technical and organizational arrangements necessary to ensure both compliance with the agreed obligations of confidentiality, as the security of personal data to which they have access as a result of this agreement and avoid its alteration, loss, processing, duplication, or unauthorized access, taking into account the state of technology, the nature of the data and information managed and the risks to which they are exposed, whether arising from human action or the physical nature.

The parties also undertake to treat personal data to which they have access or are subject to assignment in the implementation of this agreement, in accordance with the provisions of Law 15/1999, of December 13, Protection of Personal Data, as well as legislation that develops.

13. NON-COMPLETION

Either party may resolve this contract in case of default by the other party one or more of the obligations assumed under it, or that the Act provides for each.



In case of breach of obligations under this agreement from CHU, that institution has no right to claim a refund of amounts paid on account.

14. LEGISLATION AND JURISDICTION


In all matters not covered by this agreement, which is of an administrative nature, the parties submit to the Spanish legislation.

For all purposes under this agreement, the parties agree to subject to the administrative court of the Courts and Tribunals of Barcelona.


